II. VPSA - Dr. Will Simpkins (11:30 - 12p)

- A. Emergency Housing Plan
 - a. Seeing if MSU should go into the housing business. 515 student beds, housing should be similar in cost compared to UCD
 - b. Should be around \$5200 for most of their rooms and should have more psychologists, safety options, dining.
 - c. Discussion around RTD shuttles to campus, discussion around commuters being affected.
- B. Emergency Dining Ideas
 - a. Hearing lots of concerns about fees, pricing, etc.
 - b. Opportunity to offer meal plans, have one food provider, which can get them better contracts to make meal plans more affordable for everyone.
 - c. Opens the opportunity to get bigger vendors (ex. Starbucks), more space, etc.
- C. Future of the RTD Pass
 - a. Rates were set by RTD themselves based on how many people ride.
 - b. Discussing the use/need for an RTD pass
 - c. Concerns around how unsafe some stations are as well as construction. Students need the pass due to us being a commuter campus.
